[origin: WO0157736A1] In connection with a sales transaction, an electronic receipt (12) is issued to the buyer (14) that includes hyperlinks (16). A hyperlink can be associated with an inducement to make a secondary purchase of an item commercially related to the primary purchase, such as accessories, items used in the same field, manuals and other items. A hyperlink can also be associated with a product return procedure, with a manufacturer's warranty procedure, receiving rebate notices and recall notices, product registration procedures and other functions. The receipt can be maintained in a centralized database and the information used in various ways by buyers, sellers and other authorized entities.
