Abstract (en)

[origin: FR2805451A1] Device for relative displacement of two bodies (1, 2) has two main pieces (11, 12) that move relative to each other. A projecting portion (14) on the first piece (11) extends into a cavity (13) on the second piece (12) so that a conducting loop is formed in electrically conducting material that completely encloses a magnetic core. The latter is not completely enclosed by the element (100) connecting the projecting portion to the first piece (11).
