Abstract (en)

Luminous sources (10A,10B) supported on a crown (12) emit light which after passing through first optical systems (14) produces superimposed real images (11A,11B). The real images constitute a secondary light source (S) which is used with a secondary convex lens optical system (L) to produce a lighting or signalling beam. The beam may be easily modified as required by a Fresnel glass (G) or a mask
