Abstract (en)

A device for manufacturing of a preform for optical fibres through chemical deposition, including at least one gripping member rotatably mounted around an axis Z-Z and adapted to hold at least one end of at least one elongated element forming a chemical deposition substrate for the formation of a preform for optical fibres. Moreover, the chamber includes at least one burner (4), mobile along a direction Z substantially parallel to said axis Z-Z and adapted to deposit, on said at least one elongated element, a preform formation chemical substance, and at least one suction element (6) arranged on the opposite side to said at least one burner with respect to said axis Z-Z and adapted to collect exhaust chemical substances. Advantageously, said at least one burner (4) and said at least one suction element (6) are mobile from and toward axis Z-Z so as to keep the fluid dynamic phenomena regular inside the chamber during the chemical deposition process. <IMAGE>
