Abstract (en)

[origin: EP1275313A2] To produce a fabric section to be assembled into an undergarment or sportswear a paste stiffening medium (5) is applied to the single-layer fabric (1) by screen printing or adhesive coating. The printed zone gives the outer contour (3) of the garment. The fabric is then cut along a line (4) around the contour. The stiffening paste is hardened in air or by heat, and it can have a foam structure.
