Abstract (en)

[origin: WO0191431A1] To relieve a subscriber of a first terminal (T1), fixed or mobile, from consulting messages deposited in a voice message service (PCS), the voice message service notifies to the first terminal the presence of a deposited message associated with the identifier (ID2) of a second terminal (T2), immediately after unhooking and transmission of said identifier. The message (MS) is transmitted to the first terminal (T1) only if the user wishes to listen to it so as to decide whether or not to hold the call from the second terminal. Otherwise, it proceeds with the setting up of the call from the second terminal.
