[origin: US2003012098A1] The present invention is a recording method for a record medium, comprising the steps of embedding a plurality of types of management information provided corresponding to a plurality of types of record mediums as additional information to data of a content that is recorded, performing a first encoding process for the data of the content to which the additional information has been embedded, performing a second encoding process for the plurality of types of management information; and modulating the data of the content of which the first encode process has been performed and the plurality of types of management information of which the second encode process has been performed. The present invention is also the record medium.
