Abstract (en)
[origin: FR2810133A1] Sale offer acceptance data can be transmitted by an acceptance terminal (32) to a server (20) through at least a communication network including at least a public telephone network and an Internet network. The method includes a stage (10) which converts the acceptance data into another format designed for transport through another communication network and to record the converted acceptance data in the server (20). Method for connecting a sale offer transmission terminal (30) to an acceptance terminal (32) which includes: (a) A stage (1) in which an sale transaction offer message is transmitted to a broadcast center; a stage (2) for broadcasting the sale offer message; a stage (7) which connects the transmitter terminal (30) with the acceptor terminal; a communication stage (4), for a response to the offer message, which transmits to a server (20) acceptance data, emitted by the acceptor terminal (32), through a communication network. The acceptance data is recorded in the server. The transmitter terminal (30) has access, through a communication network, to the acceptance data corresponding to its sale offer message. Stage (4) is executed before connection between transmitter terminal (30) and acceptor terminal (32) is made in stage (7).
