[origin: WO0185677A1] The invention concerns novel amino acid derivatives and their use as medicines. Said derivatives have an inhibiting activity towards NO-synthase enzymes producing nitrogen monoxide NO and/or (optionally): either an activity trapping reactive oxygen species (ROS); or an activity regenerating antioxidants such as glutathion or entities trapping reactive oxygen species (ROS) and more generally an influence in the redox status of thiol group.
