Abstract (en)

A safer for a parallelepipedic cassette comprises a container with two flat sides and four mutually perpendicular narrow sides for enclosing the cassette at the flat sides and three of the narrow sides. The fourth narrow side defines an access opening through which the cassette can be inserted into and removed from the container. A detent member is mounted on one of said three narrow sides, which joins the open fourth side, and is guided for displacement transversely of the flat sides of the container between an operative position and an inoperative position. The detent member blocks the passage through the access opening in the operative position and allows the passage through the access opening in the inoperative position. A latch member is biased to lock in an engaged position engage the detent member in the operative position thereof and is adapted to be disengaged by an external mechanism to release the detent member for movement to the inoperative position. <IMAGE> <IMAGE>
