Abstract (en)
Floating reservoir comprises floating bodies (4) connected together and arranged in a body of water; and skirts consisting of rigid wall modules (99) connected together in a water-tight manner hanging from the floating bodies for delimiting and utilizing a part of the body of water. <??>An Independent claim is also included for a wall module used in the floating reservoir.
