[origin: WO0224637A1] The invention relates to cinnamic acid guanidides, to a method for the production thereof, to their use as a medicament or diagnostic reagent, and to a medicament containing these compounds. According to the invention, compounds of formula (I), in which R(1), R(2), R(3), R(4), R(5), R(6), and R(7) have the meanings cited in the claims, are excellent cardiovascular therapeutic agents. These are obtained by reacting a compound of formula (II) with guanidine.
