[origin: WO0230851A2] The invention relates to a method for the hydrogenation of unsubstituted or at least monoalkyl substituted uni- or poly-nuclear aromatics by means of bringing the above at least one aromatic into contact with a gas containing hydrogen, in the presence of a catalyst comprising at least one metal of sub-group VIII of the periodic system as active metal, supported on a structured or monolithic support.
