Abstract (en)
[origin: EP0944112A2] The bulb has a current supply unit (7), which is U-shaped with a base (15) and two limbs (16). The ends of the limb engage in the end region (6) of the radiant body by means of hook parts (20). A section (11) at the radiant body side end of the associated foil is folded back and forms a catch (12), in which the base is mechanically held.
