Abstract (en)

[origin: WO02062748A1] The invention relates to anti-thrombotic compounds of general formula (I), wherein R1 - R4, R8, R9 and Ar are defined as cited in claim 1, and for example, 2-(5-carbamimidoyl-2-hydroxy-phenyl)-N-[3-chloro-4-(pyrrolidine-1-yl-carbonyl)-phenyl]-acetamide, tautomers thereof, stereoisomers, mixtures, pro-drugs and the salts thereof. The compounds of the above-mentioned general formula (I), wherein Ar represents a phenyl or naphthyl group substituted by the radicals R5, R6 and R7 and R5 represents a cyano group, having valuable intermediate products for producing the corresponding compounds of general formula (I) wherein R5 represents, optionally, a amidino group substituted by one or two C1-3 alkyl groups. The compounds of the above-mentioned general formula (I) with the exception of compounds, wherein Ar represents a phenyl or naphthyl group substituted by the radicals R5, R6 and R7 and R5 represents a cyano group, have valuable pharmacological properties, particularly anti-thrombotic properties and a factor Xa inhibiting property.
