[origin: EP0901923A2] A motor generator (M) has a rotor (48) directly coupled to a crankshaft (28) and a stator (50) disposed around the rotor (48). A shield plate (80) is disposed between coils (70) of the stator (50) and an internal combustion engine (E).
