Abstract (en)

[origin: WO02068777A1] The present invention advantageously provides an enhanced event-based theater going experience. In particular, one embodiment of the present invention enables pre-recorded videos of live performances, such as concerts, to be reproduced with great realism and encourages theater attendees to act or feel more as participants and less as passive viewers. The theater (100) optionally comprises a projection screen (105), a projection room (110), seating (120), a dance area, an MC (130) (master of ceremonies) station, changeable scenic designs, special effects equipment, food services and/or a bar (135).
