Abstract (en)

The cosmetic product (P) is supplied in a container e.g. with a base (4) and is accompanied by one or more applicators (3). Each applicator has an adhesive surface (9) that allows it to be attached to a finger tip, and can be circular in shape, with a radius equivalent to at least two-thirds of its thickness. The cosmetic product (P) is supplied in a container e.g. with a base (4) and is accompanied by one or more applicators (3). Each applicator has an adhesive surface (9) that allows it to be attached to a finger tip, and can be circular in shape, with a radius equivalent to at least two-thirds of its thickness. The applicator, which is not impregnated with the product prior to first use, has an application surface of a flocked, woven or non-woven material. It can be made from a foam material with an abraded surface to provide a cushioned effect, an elastomer or a multi layer material, and can be impregnated with a biocidal agent or magnetic particles. The adhesive is hypoallergenic, and can be applied in spots or strips.

La présente invention concerne un dispositif pour l'application d'un produit cosmétique, caractérisé par le fait qu'il comporte un récipient (2) contenant le produit (P), et un applicateur (3) pouvant être logé dans le récipient (2) ou fixé sur celui-ci, cet applicateur (3) étant pourvu, avant la première utilisation, d'une surface adhésive (9) permettant la fixation de l'applicateur (3) sur la peau, un cercle (C) d'axe (X) circonscrit à l'applicateur (3) présentant un diamètre supérieur à l'épaisseur maximum (emax) de l'applicateur, mesurée parallèlement à l'axe (X). <IMAGE>
