[origin: WO02083966A1] The invention relates to a tool steel, whereby the composition thereof comprises the following expressed in wt. %: 0.8 </= C </= 1.5; 5.0 </= Cr </= 14; 0.2 </= Mn </= 3; Ni </= 5; V </= 1; Nb </= 0.1; Si+Al </= 2; Cu </= 1; S </= 0.3; Ca </= 0.1; Se </= 0.1; Te </= 0.1; 1.0 </= Mo+W/2 </= 4; 0.06 </= Ti+Zr/2 </= 0.15; 0.004 </= N </= 0.02. The rest of the composition is comprised of iron and impurities resulting from the production process, including 2.5.10<-4> %<2> </= (Ti + Zr/2) x N. The invention also relates to a method for producing parts made of said steel and parts thus obtained.
