Abstract (en)
[origin: DE10105143A1] The invention relates to a method for providing textile material with UV protection, whereby (a) zinc oxide and/or titanium oxide are applied to the textile material as constituent A, and (b) at least one organic UV absorber is applied to the textile material as constituent B. Constituent B preferably contains at least one compound from the group consisting of phenylbenzotriazoles, dibenzoylmethanes, p-aminobenzoic acid esters, cinnamic acid esters, salicylic acid esters, nitrogen-free 2-hydroxybenzophenones, phenylbenzimidazoles, acrylates, diarylbutadienes, amino-substituted hydroxybenzophenones, and triazines.
