Abstract (en)  
[origin: WO0239961A1] The invention concerns a composition in particular cosmetic for care or make-up of the skin and/or skin appendages and/or lips, capable of being in the form of a cast product comprising in a physiologically acceptable medium containing at least a fatty liquid, a colloidal dispersion of solid particles at room temperature in particular coloured and a dispersion of polymer particles surface-stabilised in said fatty liquid phase by a stabilising agent. The invention is characterised in that, depending on the amount of polymer, it enables to obtain on the skin or skin appendages or the lips a brilliant soft film coat, while providing great comfort. The invention also concerns a method for care or make-up of the skin, skin appendages and the lips using said composition.
