[origin: US2004237981A1] A printing unit for applying print marks to a wrapping strip in a cigarette rope machine of the tobacco processing industry is provided. The printing unit includes at least one printing cylinder, a counter-pressure cylinder in contact with the at least one printing cylinder, and a fastening device adapted to jointly attach and detach the at least one printing cylinder and the counter-pressure cylinder to the cigarette rope machine.
