Abstract (en)  
[origin: WO03002691A1] The invention is used for the pyrolysis and gasification of material mixtures containing organic components. The organic materials or the material mixture containing organic components are brought into contact with a heat transfer medium, preferably the ash from a combustion reactor, and pyrolysed in a pyrolysis reactor, preferably a shaft reactor. The coke which is generated by pyrolysis is combusted with an air supply in a combustion reactor, preferably in a fluidized bed reactor. The condensable components of the crude gas which is generated by pyrolysis are cracked in a cracking reactor, preferably by means of a catalyst. In order to improve said method, the heat transfer medium is transported using overheated steam (50) as a fluidizing medium.
