Abstract (en)
[origin: DE10130061A1] For purchasing a service, especially an access authorization, by way of a mobile data terminal on a service or access terminal (6) a plurality of reservation terminals (2) for short-range wireless data transmission are established. In order to reserve a service, a link (3) between the mobile data terminal (4) and one of the reservation terminals (2) is established and the service is reserved using the data terminal (4). The reserved service is deposited either by data transfer (12) from the reservation terminal (2) to the data terminal (4) or after a transfer (14) of data for the identification of the data terminal (4) from the data terminal (4) to the reservation terminal (2) on the service terminal (6) or a data service (15) so as to purchase the service, that is for example to gain access.
