[origin: EP1281392A1] Process for producing a *Cajanus cajan* extract comprises extracting *Cajanus cajan* plants with a solvent selected from water, lower alcohols, esters, hydrocarbons, ketones, halogenated hydrocarbons and their mixtures, and optionally drying the extract. An Independent claim is also included for a cosmetic or pharmaceutical composition comprising a *Cajanus cajan* extract.
