[origin: WO03007847A1] A bioprosthetic device(610) is provided for soft tissue attachment, reinforcement, and or reconstruction. The device (610) comprises a naturally occurring extracellular matrix portion (612) and a three-dimensional synthetic portion (624). In illustrated embodiments, the naturally occurring extracellular matrix portion (612) comprises layers of small intestine submucosa, and the three-dimensional synthetic portion comprises a foam or a three-dimensional mesh, textile or felt.
