Abstract (en)

[origin: WO03008529A1] The invention concerns a method for treating a surface with a gel, and a treating gel. The treatment may for example consist of a decontamination, stripping or degreasing treatment of a surface. The method comprises the following successive steps: applying the treating gel on the surface to be treated; maintaining the treating gel on the surface to be treated at a temperature and relative humidity such that the gel dries when breaking up and that it has sufficient time to treat the surface before forming a dry and solid residue; and eliminating the dry and solid residue from the treated surface, by suction or brushing. The gel comprises a viscosifier, a treating agent and optionally an oxidising agent.
