Abstract (en)

[origin: WO03028615A1] The invention relates to a massage system (1) comprising at least one massage device (2, 2', 2A, 2A'; 20) that, in turn, has at least one massage element (3 to 6 or 21 to 23) as well as a holding element (7, 8 or 24) for holding the massage elements. A drive (9; 26) is provided for the massage device (2 to 2A'; 20), and a transmission device (10, 10'; 25) is provided for transmitting a massage movement from the drive (9; 26) to the massage device. The message system is particularly designed for installation inside the backrest (11) of a vehicle seat (S). The holding element (7, 8; 24) and the transmission device (10, 10'; 25) are combined to form a functional unit that performs a multi-functional massage, whereby the output shaft (19; 27) of the drive (9; 26) is directly connected to the functional unit.
