[origin: WO03029098A1] The invention relates to a device which is intended, in particular, for the application and/or packaging of a cosmetic product. The inventive device comprises a fibrous, cellular or porous element (3) which is fixed to a support (2). The element is connected to the support at least by means of the material of a projecting part (10) of the support which penetrates the pores, cells or between the fibres of the element.
