Abstract (en)  
[origin: EP1433539A2] The container (1) includes a casing (2) with at least one inlet (4) and outlet (8, 9). Inside it is a fluidizing bed(5) of air-permeable material, forming a pressure cavity (6) between the fluidizing bed and the floor of the casing, to which compressed air is supplied. The cross section of the casing narrows downwards towards the fluidizing bed.
