[origin: WO03039493A1] Self-foaming, foamed, post-foaming or foamable cosmetic and dermatological preparations comprising I) and emulsifier system consisting of A) at least one emulsifier (A) selected from the group of fully, partially or non neutralized, branched and/or unbranched saturated and/or unsaturated fatty acids having a chain length of 10-40 carbon atoms, B) at least one emulsifier (B) selected from the group of polyethoxylated fatty acid esters having a chain length of 10-40 carbon atoms and a degree of ethoxylation of 5 - 100 and C) at least one co-emulsifier (C) selected from the group of saturated and/or unsaturated, branched and/or unbranched fatty alcohols having a chain length of 10 -40 carbon atoms, also comprising II) up to 30 wt. % - in relation to the overall weight of the preparation of a liquid phase which contains a) one or several lipids from the group of silicone oils and silicon waxes and b) one or several lipids from the group of unpolar lipids having a polarity \geq 30 mN/m, the ratio of (a) to (b) ranging from 1:3 - 3:1.
