[origin: WO03045048A2] The invention relates to a device and method for scanning an original copy (10) using a camera (20) containing a line sensor. Means are provided that, during the scanning process, hold, in an essentially constant manner, the optical path length (w) between the camera (20) and the line that is to be currently scanned, whereby the camera (20) executes a lifting and rotational movement.
