[origin: WO03058940A2] According to the invention, ergonomic and efficient billing of service-related and private conversations can be achieved by a method for billing (8) a conversation (4) carried out by a user (1) of a mobile radio terminal (1) using said mobile radio terminal and a mobile radio network. The inventive method is characterised in that following an input (2) of the user (1) into the mobile radio terminal, indicating whether a conversation is to be billed as service-related or private, a message representing said input (2) is sent (4) to the mobile radio network (5).
