[origin: EP1464415A2] Process for hot and cold rolling of metal bands (18) especially on flexible rolls of bands of variable thickness where at least one band storage device (23,33) is in the form of a S and on rolling with controlled motion of at least one of the rolls (24,25,34,35) the band storage device is so deformed that the length of the metal band between entry into and exit from it is altered. An independent claim is included for a rolling unit for flexible rolling of bands of variable thickness.
