Abstract (en)  
A vane pump assembly has a rotor pump (2) with a pump housing (10), and a pump zone (12). A rotor (16) rotates within the pump zone, with sliding vanes (18) against the inner peripheral wall (34) to divide the pump zone into two chambers. The vane pump assembly has a rotor pump (2) with a pump housing (10), and a pump zone (12). A rotor (16) rotates within the pump zone, with sliding vanes (18) against the inner peripheral wall (34) to divide the pump zone into two chambers. The vanes have a relative movement in relation to the rotor and the inner wall, and at least one of the moving components has an insert (20,22) forming a mounting, of metal, ceramics, a sintered material or a plastics. The rotor and/or the vane and or the inner wall of the pump zone are of a plastics material.

Abstract (de)  
Die Erfindung betrifft eine Rotorpumpe (2) mit einem Pumpengehäuse (10) mit einem Pumpenraum (12), eine im Pumpenraum drehbargelagerten Rotor (16), einen im Rotor verschieblich gelagerten Flügel (18), der den Pumpenraum in zwei Kammern unterteilt und an der Innenumfangswand (34) des Pumpenraums anliegt, sodass der Flügel bezüglich des Rotors und bezüglich der Innenumfangswand eine Relativbewegung ausführt, wobei wenigstens ein Teil der zueinander relativbewegungen ausführenden Bauteile mit einer ein Lager bildenden Einlage (20,22,38,40) versehen ist.
