[origin: WO03068224A2] The invention relates to the use of inhibitors of the sodium-dependent chloride-bicarbonate-exchanger for treating thrombotic and inflammatory diseases. Said inhibitors of the cellular sodium-dependent chloride-bicarbonate-exchanger exhibit an inhibiting effect on the secretion of the Von Willebrand-factor. Said inhibitors can be used in the treatment of thrombotic and inflammatory diseases.
