Abstract (en)

[origin: WO03074924A1] The invention relates to an aircraft comprising a number of lifting rotors and propulsion rotors, provided with an electric motor for each rotor and with a power inverter for each motor. The aim of the invention is to provide an aircraft that has a higher load capacity. To this end, connecting bars are provided between the motors. The invention is based on the finding that connecting bars of this type, when they are arranged in the form of a lattice, enable a light yet stable structure of the aircraft that, correspondingly, can carry heavier loads.
