[origin: WO03080015A1] The invention relates to cosmetic or dermatological preparations containing 9-retinal and/or 9-retinal alkanolamine Schiff base of structural formula (I), wherein R = R'(OH)_n, branched or unbranched alcanol. The use of 9-retinal and/or 9-retinal alkanolamine Schiff base leads to the induction and intensification of tanning mechanisms of the skin and intensification of hair color.
