Abstract (en)
[origin: WO03082034A1] A parent (1) puts on an adult garment (100), and in a state in which a baby (2) is held under a person's arm in a child carrier (200), male buckles (209, 225) of the child carrier (200) are joined to the female buckles (104b, 106b) of the upper connections installed in the adult garment (100) while the clip (230) of the child carrier (200) is engaged with the annular buckle (107b) of the lower connection installed in the adult garment (100). This arrangement makes it possible to provide an adult garment, a child garment and a parent-child garment, which ensure that a person, when wearing, looks the same in external impression as when wearing an ordinary garment, which have the function of a nursing band, which are highly fashionable and casual, and which can be used even by males without a feeling of wrongness.
