[origin: WO03087057A1] The invention concerns a compound of the formula (I) wherein Ring A is heterocyclyl; m is 0-4 and each R<1> is a group such as hydroxy, halo, trifluoromethyl and cyano; R<2> is halo and n is 0-2; and each R<4> is a group such as hydroxy, halo, trifluoromethyl and cyano; p is 0-4; and R<3> is amino or hydroxy; or pharmaceutically-acceptable salts or in-vivo-hydrolysable ester or amide thereof processes for their preparation, pharmaceutical compositions containing them and their use in the treatment of diseases or medical condions mediated by histone deacetylase.
