Abstract (en)
The compact (1) comprising a base with a hinged lid incorporates a sliding drawer with a catch (24) to hold it closed and a spring (21) to open it. The spring is in the form of one or more flexible strips that can be attached to the back of the drawer or molded in one piece with it e.g. by injection, and compressed against the rear wall of the compact base when closed. The catch is in the form of a tongue designed to engage with a notch (28) in the bottom wall (7) of the base, and is released by pressing on a tab (27) in the base. The sides of the drawer have projecting rails that slide in grooves in the compact base, and it has a stop (30) to prevent it from sliding completely out of the compact.
