Abstract (en)

A system for visualizing one or more images to one or more viewers in motion comprises: (a) means (18,19) for receiving a series of at least one original images; (b) an extended span of screen (13); (c) a sequence of projectors (121-12n) mounted along the said screen (13); (d) means (111) for dividing the frame of each image in the said series of original images into a number of sub-images and shifting the dividing lines on the frame of each image, frame by frame, according to a function of the moving velocity of the said viewers, such that the said series of original images are split into a number of series of shifted sub-images; and (e) means for projecting each series of said shifted sub-images on the said screen separately by one of the corresponding said projectors (121-12n), such that one or more complete images are displayed on the said screen, and the display positions move on the said screen according to a function of the velocity of the said viewers. <IMAGE>
