[origin: EP1557204A2] Racket (2) comprises a racket head (6) and a frame (4) with a connected grip section (10). The racket head defines a tensioned surface and the frame profile has four trough-shaped indentations (12) lying opposite each other and arranged symmetrical to the longitudinal axis of the racket.
