Abstract (en)  
A lid for a mug or the like container for beverages includes a base body (4), wherein the base body (4) includes at least one recess (10) which is defined by a sidewall (8) and a bottom wall (9), said recess (10) forming a receiving space for food or the like. According to the invention the bottom wall is located in the axial direction of the base body (4) in a plane defined by the lower rim (25) of the base body (4) or in a plane spaced apart from the plane defined by the lower rim (25) towards the upper rim of the base body (4), such that the bottom wall (9) does not protrude over the lower rim (25) of the base body (4). <IMAGE>
