Abstract (en)
[origin: EP1584260A2] The applicator (1) to prepare an apply a product, especially a cosmetic skin cream, has a handle (5) with a two-part container for the product. The container parts are of different materials. The second part (20) of the container, which can be rotated around an axis (X) in relation to the first part (10), has at least one surface in contact with the product in the container, so that its rotation applies a pressure moving the product towards the applicator e.g. a foam pad. The appliance also incorporates a mirror (90).
