Abstract (en)
[origin: EP1614483A2] Device for coating a strip-like substrate (1), especially a textile, with a coating composition (9.1) comprises a lower doctor blade (4) arranged below the substrate to apply the coating composition against the lower side (1.1) of the substrate. An independent claim is also included for a process for coating a strip-like substrate using the above device. Preferred Features: An upper doctor blade (5) arranged above the substrate can be applied against the surface of the substrate, The lower doctor blade is arranged in front of or after the upper doctor blade in the running direction of the substrate.
