[origin: EP1617139A1] A pipe (1) in a fire tube boiler, designed to convey the combustion gases and to be struck at its outer surface by the water to be heated, comprising a wall (2) which has a constant thickness along its entire length and a plurality of fins which protrude monolithically from at least one arc-like support (3,4), which is associated in contact with the internal surface of the wall.
