Abstract (en)
[origin: WO2004093578A2] The invention relates to protective clothing made of a multi-layered textile. A microfine inner layer which is highly tight but permeable to water vapour is arranged between two layers of a polypropylene spun-bonded fabric. The inner layer formed by meltblown is hydrophilized and said layer can absorb from 500 - 600 %, preferably, up to 800 % of the weight thereof in liquid.
