Abstract (en)

The invention relates to a luminaire for zone 0 hazardous areas. The luminaire (1) comprises an illuminator (4.1), and a cable (3) for supplying electric power to illuminate the illuminator (4.1). The luminaire (1) further comprises an illumination unit (4) comprising a body (4.2) in connection with which the illuminator (4.1) is attached, and a protective cover (4.3) placed above the illuminator (4.1) for protecting the illuminator (4.1). The free space of the body (4.2) is filled with a filler to make the illumination unit (4) substantially gas tight.
