Abstract (en)
Each protective finger strip (3) is formed by a beam of connected sections (10) forming a single piece. Transverse slotted penetrations (11) permit relative movement of the sections in two opposite directions. Studs (5) carried on a band (4) are inserted into slot locations (9) provided in the bands.
